## Service Pricing

- **Bride – Hair:** \$120
  - **Bride – Makeup:** \$140
  - **Bridesmaids – Hair (each):** \$120
  - **Bridesmaids – Makeup (each):** \$140
- Makeup services include false lash application if desired.*
- 

## Fees

- To reserve your wedding date, a **\$300 non-refundable on-location fee** must be submitted.
    - Covers round-trip travel up to 75 miles.
    - Additional \$50 per 25 miles beyond 75 miles (rounded up).
      - Payment methods:
        - **Credit/debit card** (via phone or in person)
        - **Cash or check** (via mail or in person)
      - \* (a 4% merchant fee is added to **every** deposit)\*
      - Must be paid within 30 days of the deposit to remain on the schedule.
  - **Outside Hours Fee:** \$400
    - Applies to weddings booked **outside of Tuesday–Saturday business hours** or on **national/bank holidays**.
      - -applies to Memorial day Saturday, Labor day Saturday, 4th of July weekend (when it falls on a Thursday), & the Saturday before Christmas

## Bridal Trial & Payment

- **Bridal trials are priced separately** from day-of wedding services and are not included in the service total or on-location fee.

- We are a high volume full service salon so we ask that you call/text to schedule your trial at least *three months in advance*. Due to the salons limited availability **brides** are the only guests able to be serviced for a trial.
  - Trials are completed during regular business hours therefore for timing purposes we cannot guarantee hair and makeup trials will be scheduled together.
  - A **credit card must be placed on file** to secure a trial appointment.
  - **Cash is the required method of payment** for services on the wedding day.
  - **Gratuity is not included** in pricing.

## Destination & Overnight Travel

Weddings requiring overnight accommodations or travel exceeding 150 miles from 11 AM Salon may be subject to additional travel compensation fees.

Client is responsible for all travel expenses including airfare, baggage fees, hotel accommodations, parking, tolls, rideshare services, and rental vehicles when applicable.

A travel day fee of \$500 per artist, per travel day, will be charged for any day in which travel prevents the artist from accepting appointments at the salon.

Travel fees will be quoted and agreed upon in writing before contract execution.

## Service Adjustments & Additions

- To **remove any contracted services or persons**, please notify the salon **no later than 30 days before** the wedding to avoid penalty.
  - To **add services or individuals**, notify the salon **at least 30 days before** the wedding.
  - Additions made **within 7 days** will be scheduled only **if time permits**, on a **first-come, first-serve basis**.
- 

## Cancellation Policy

- The \$300 on-location fee is **non-refundable**.
- Cancellations made **within 6 weeks** of the scheduled wedding will result in a **charge of 50%** of the quoted services.
- Cancellations made **within 48 hours** will be charged **100%** of the quoted services.
- In the case of non-payment on the wedding day, the **credit card on file will be charged**.
